The National Commission on the Rights of Child (NCRC) is an independent statutory body established by the Government of Pakistan for the promotion, protection, and fulfilment of children's rights in Pakistan. The NCRC has the mandate to examine and review policies, laws, practices, and proposals, inquire into violations of child rights, conduct research, raise awareness, build capacities, provide technical support and advise the Government on legislative and policy matters by virtue of the National Commission on the Rights of Child Act, 2017.

Legal & Policy Reforms

Advocacy for Prohibition of Child Domestic Labour Bill, 2023

The NCRC stands at the forefront of legislative change with the groundbreaking Prohibition of Child Domestic Labour Bill 2023. This initiative is set to elevate CDL to a non-compoundable and non-bailable offence, marking a profound step in the protection of children from child domestic labour.

Yet, we understand that true transformation transcends mere laws; it necessitates the collective commitment of society. That's why the NCRC launched a dynamic social media campaign, rallying widespread support to criminalize CDL.

Moreover, the NCRC is actively seeking feedback from and collaboration with civil society, child rights experts, and an advisory committee to refine and strengthen the bill. We are dedicated to an inclusive approach that leverages the expertise and insights of stakeholders in crafting the most effective legislation.

As we look ahead, the NCRC remains unwavering in its commitment to advocate for this bill and will work tirelessly with the new government post-election.

Reviewed ICT Child Protection Policy


Endorsed Child Marriage Restraint (Amendment) Bill, 2023

In a proactive step towards safeguarding the rights of children, the NCRC undertook a comprehensive review of the Child Marriage Restraint (Amendment) Bill, 2023 for ICT, moved by Senator Bahramand Khan Tangi. During this process, the NCRC provided detailed input to the Senate of Pakistan, advocating for crucial enhancements to the legislation. Specifically, the NCRC supported the augmentation of punishments for contracting, solemnizing, promoting,

or permitting child marriages. This strategic move aims to curb the practice of child marriage and establish stronger deterrence against this harmful tradition. The input provided by the NCRC underscores its unwavering commitment to advocating for legal reforms that protect the rights and well-being of children, further strengthening our nation's resolve to eradicate child marriage.

Brief to Supreme Court on Child Trafficking and Child Sexual Abuse

In a determined effort to safeguard the rights and well-being of children, the NCRC has submitted a comprehensive brief to the Supreme Court, addressing the pressing issues of child trafficking, child abuse, and child cruelty. This document delves into the intricate socio-economic and cultural context of Pakistan, shedding light on the backdrop against which these issues must be understood. It meticulously examines the domestic legal and policy frameworks in place, discussing both general and specialized legislation, such as the Prevention of Trafficking in Persons Act 2018 (PTPA). The NCRC critically evaluates these legal frameworks, aiming to identify any shortcomings and gaps that need to be addressed. Additionally, the brief explores international legal instruments related to these issues and provides suggestions for legislative and institutional reforms, as well as general recommendations.



Attending Senate & National Assembly Standing Committee Meetings

In a quarter marked by an unwavering dedication to child rights and the eradication of CDL, the NCRC appeared before the Senate's and National Assembly's Standing Committee on Human Rights not once but in four different meetings. These appearances underscored the NCRC's commitment to fostering meaningful change for children in Pakistan.



During these engagements, the NCRC team

provided comprehensive briefings on crucial matters pertaining to child rights and CDL, highlighting the progress made in the recent CDL cases. These discussions were not just about monitoring progress but also outlining strategic measures to prevent such cases in the future.

These engagements with the Senate and National Assembly Committees were emblematic of the NCRC's tireless efforts to advocate for child rights and address pressing issues that affect children's lives.

Coordination

The NCRC Convenes Inaugural Advisory Committee Meeting to Combat Child Labour and Child Trafficking

The NCRC commenced its inaugural advisory committee meeting on July 19 2023, followed by 2nd meeting of the advisory Committee on September 27 2023. Esteemed child rights experts, policymakers, CSOs and other government stakeholders gathered to address critical issues concerning CDL and child trafficking, with a shared commitment to strengthening preventive measures and upholding the rights of children.

The Advisory Committee emphasized the need for an in-depth analysis of the current landscape, focusing on the root causes and far-reaching impacts of child labour and child trafficking. It also explored avenues to enhance awareness, advocacy efforts, and partnerships between government agencies, NGOs, and civil society.

The advisory committee meetings yielded a comprehensive set of recommendations covering various aspects of the proposed legislation to criminalize CDL. These recommendations are geared towards strengthening the bill and closing potential loopholes. The resounding consensus among committee members was that CDL must be treated as a grave offence, devoid of any compromises. The bill will explicitly prohibit compounding and bail in such cases, sending a strong message against child exploitation.

These advisory committee meetings underscore the NCRC's unwavering dedication to safeguarding children's rights while taking into account the recommendations made by the experts from child rights experts.



Chairperson NCRC Ayesha Raza Farooq Calls upon the Caretaker Prime Minister in the wake of the Surge in CDL Cases





In light of the recent heart-wrenching cases involving Rizwana and Fatima, the Chairperson of NCRC, Ayesha Raza Farooq, took a significant step by meeting with Caretaker Prime Minister Anwaar Kakar to apprise him of the alarming situation regarding child exploitation and child labour in our country.

Caretaker Prime Minister Kakar reaffirmed his unwavering commitment to utilizing all available resources to support the NCRC. He made it clear that stringent legal action would be taken against those who violate children's rights, ensuring swift justice. Moreover, he promised unwavering support for the NCRC in its noble mission to safeguard the well-being of our young ones. This meeting underscores the government's dedication to eradicating child exploitation and ensuring that children's rights are upheld and protected.

Meetings with Key Government Stakeholders



In a proactive effort to bolster child protection mechanisms and facilitate collaboration, the NCRC Chairperson Ayesha Raza Farooq, accompanied by Member Punjab Mehek Naeem and Member ICT Mr. Khalid Naeem, held a crucial meeting with Chief Provincial Commissioner for Children, Punjab, Tabana Sajjad Naseer. This constructive meeting aimed at deepening the understanding of respective mandates and, more importantly, exploring avenues for synergistic collaboration. The gathering also emphasized the critical need for

reinforcing complaint mechanisms, ensuring that the voices of children are heard and acted upon.

The NCRC team recently had the honour of meeting with the Special Assistant to the Prime Minister on Human Rights, Mushaal Mullick. During this engaging meeting, we had the invaluable opportunity to illuminate the essential mandate and impactful work carried out by the NCRC, with a specific focus on safeguarding the rights of vulnerable children. SAPM Mushaal Mullick expressed her wholehearted support and appreciation for our cause, reaffirming the government's dedication to advancing child rights in Pakistan.

Chairperson NCRC Ayesha Raza Farooq spearheaded a significant meeting with the Federal Law Minister and Secretary. The focal point of this crucial discussion was the formulation of the National Sex Offender Register Rules, 2023 and recent surge in the CDL cases. The formulation of rules is a momentous development in the fight against sexual offences. The National Sex Offender Register Rules, 2023,

hold immense promise in addressing the grave issue of sexual offences by creating a comprehensive database of sex offenders.

Chairperson NCRC Ayesha Raza Faroog and the Commission members called upon the the Federal Minister of Human Rights Khalil George. The primary objective of this meeting was to discuss the critical situation of child rights issues, both at the federal and provincial levels of governance. During this meeting, the NCRC delegation addressed the pressing concerns surrounding child rights in Pakistan. They highlighted the need for comprehensive measures to protect children from various forms of exploitation, including child labour, lack of access to quality education, and inequitable healthcare. The Minister assured the NCRC of his full support in their mission to uphold and protect the rights of children throughout the country.








Inquiries Related to Child Rights Violations

Complaint Handling

The NCRC's commitment to the well-being of children remained steadfast as we addressed a total of 86 complaints related to children's rights. These cases serve as a poignant reminder of the vital role the NCRC plays in advocating for and protecting the rights of children. Each complaint

handled represents a child whose voice was heard and whose rights were defended, reinforcing our dedication to creating a society where children can thrive without fear or injustice.

Addressing Child Rights Issues

Participating in SDG's Side Event on CRVS Facilitated by UNICEF

In a significant stride towards advancing the Civil Registration and Vital Statistics (CRVS) system, the Chairperson of the NCRC, Ayesha Raza Farooq, represented Pakistan at a crucial Sustainable Development Goal's (SDG's) side event facilitated by UNICEF in New York. Addressing the event, she underscored the imperative of strengthening the CRVS system through a multifaceted approach. These included prioritizing interoperability with the health sector, facilitating fee waivers within legally permissible timeframes, streamlining

business processes for enhanced efficiency, and fostering collaboration with the education, nutrition, and social protection sectors. This strategic emphasis on aligning CRVS with these vital sectors not only aligns with SDG 16.9 but also demonstrates Pakistan's commitment to achieving comprehensive and inclusive development. The Chairperson of NCRC was applauded for her advocacy in driving positive change and putting Pakistan at the forefront of global CRVS initiatives.







Attending the Regional Consultation of Child Rights Institutions in South Asia Facilitated by UNICEF

In a testament to the NCRC's commitment to championing child rights not only within Pakistan but across the South Asian region, our esteemed Chairperson and two members of the Commission participated in a pivotal regional consultation of Child Rights Institutions in Maldives with the facilitation of UNICEF and presented the progress of the Commission. With unwavering dedication, she introduced the NCRC's mandate and highlighted our ongoing efforts in the implementation of the Convention on the Rights of the Child



(CRC) and the promotion and protection of children's rights. The Commission was appreciated as it is the only CRI in the region with two child members.

Children's Consultations

The NCRC, in partnership with UNICEF, organized a series of children-led consultations on child rights that reverberated across Pakistan. The epicenter of this transformative movement was the National Assembly of Pakistan, where dynamic discussions at the event titled "Children in the Lead: Voices Unleashed" took place. Young changemakers took the reins, sharing their invaluable insights on a myriad of pressing issues affecting their lives, from child labour to child marriage, violence against children, education, online protection, mental health, climate change, gender, disabilities, and social inclusion, among others.

But the ripple effect extended far beyond the National Assembly. Following this event, consultations with children were held in Multan, Quetta, Peshawar, and Hyderabad. These consultations formed a mosaic of child participation and empowerment, allowing children's voices to resonate nationwide. It was an embodiment of the commitment to ensuring that children's voices are not only heard but also valued and acted upon. The children presented a treasure trove of recommendations on various issues, each recommendation a call to action for policymakers and stakeholders to prioritize child-centred policies.













Consultations with CSOs

The NCRC orchestrated a series of provincial consultations (in Punjab and Sindh) and stocktaking workshops (in Khyber Pakhtunkhwa, Punjab and Sindh), engaging civil society, experts, and advocates in crucial dialogues on child rights, protection, and the prevention of child sexual abuse and exploitation. These events emerged as pivotal platforms for stakeholders to unite, assess progress, and collectively chart a course for a safer and more nurturing environment for children. These consultations allowed for the exchange of invaluable insights and the forging of partner-

ships aimed at bolstering child protection mechanisms.

Furthermore, the "Stocktaking Workshop on Child Protection Prevention Activities" in both Punjab and Sindh served as a dedicated space for stakeholders to assess the efficacy of existing child protection and prevention initiatives. These workshops delved deep into the heart of the matter, providing a platform for self-reflection and a critical evaluation of the progress made in safeguarding children from abuse and exploitation.





Ensuring Quality Care for Children: NCRC's Visits to Islamabad Orphanages

In line with its empowering mandate, the NCRC embarked on a mission to safeguard and enhance the welfare of children across Pakistan. With an unwavering commitment to the best interests of the child, the Commission recently took a vital step by visiting orphanages within the vicinity of Islamabad to ensure that minimum quality care standards were being applied in these facilities.

The NCRC team's visits extended to four orphanages: EDHI Homes, Pakistan Sweet Homes, Al-Khidmat Aghosh Homes, and SOS Village. By engaging with these orphanages and conducting thorough assessments, the Commission aimed to not only monitor existing practices but also make recommendations to enhance the implementation of child rights policies.

Chairperson of NCRC, Ayesha Raza, met with Mr. Zamurad Khan from Pakistan Sweet Homes, a heartwarming organization dedicated to providing shelter and rehabilitation to homeless children. In this heartfelt meeting, Chairperson Ayesha Raza extended her deep appreciation for the unwavering efforts of Pakistan Sweet Homes in transforming the lives of these vulnerable children.

The Commission remains steadfast in its mission to ensure that all children, regardless of their circumstances, are provided with the care, support, and opportunities they deserve. These visits to Islamabad's orphanages are a powerful example of the NCRC's proactive efforts to create a safer, more nurturing environment for the nation's children.

Research & Database

Policy Brief on Child Trafficking

The NCRC is finalizing a policy brief on 'Child Trafficking' aimed at creating perspectives for lawmakers, judges, and law enforcement agencies by identifying gaps in legal and policy frameworks on the issue of child trafficking. Not only that, but the policy brief also attempts to make recommendations to fill the legislative lacunas and further suggests reforms on the

institutional side for the effective implementation of the laws. While laws alone cannot root out the problem unless the structural factors which serve as the root causes are also addressed, an effort has also been made to make recommendations that can be used to address the root causes of child trafficking in the country.

Reviewing International Commitments

Report on CEDAW

The NCRC submitted a comprehensive report to the Ministry of Human Rights detailing progress made against recommendations put forth by the Committee on the Elimination of Discrimination against Women (CEDAW) with special focus on girl child in the periodic progress report.

This report provides critical insights into several key areas, including the prosecution and punishment of child marriage and forced marriage cases, awareness-raising campaigns combating discriminatory stereotypes, and the number of government-funded programs dedicated to preventing child marriage and forced marriage.

This commitment extends to ensuring that the rights and dignity of women and girls are upheld, and discriminatory practices are eradicated. The NCRC remains steadfast in its dedication to building a more inclusive and equitable society where every individual can thrive free from discrimination and violence.

Awareness Raising

Meeting with Chairman PEMRA

The NCRC is grateful for the unwavering commitment demonstrated by Chairman PEMRA in our recent meeting. The promise to dedicate airtime to raise awareness on child rights and lead advocacy and awareness campaigns is a significant leap forward in our collective mission.

The NCRC in Media

Child Labour and Human Trafficking: The NCRC's Chairperson Ayesha Raza Farooq engaged with Ananke editor to shed light on child labour issues within the context of modern slavery and human trafficking, inviting everyone to join us in supporting a brighter future for every child.

Urgent Action Against Child Labour Torture: The NCRC's Chairperson Ayesha Raza Farooq addressed the alarming increase in torture cases involving child domestic laborers during an interview with 92 NEWS. She emphasized the urgency of the matter and our active engagement with key stakeholders to advocate for the criminalization of CDL as a non-bailable and non-compoundable offense, reflecting our unwavering commitment to child safety and



rights.

Passionate Plea for Change: As cases of CDL surged, Chairperson Ayesha Raza Farooq passionately called upon all key stakeholders in an interview with ARY News to take decisive action by criminalizing CDL under the Pakistan Penal Code (PPC), stressing the need to protect the rights and well-being of our children.

Justice for Rizwana: Taking a resolute stance, Chairperson NCRC Ayesha Raza demanded comprehensive FIRs in cases like Rizwana's torture case during an interview with NEO News. She emphasized our commitment to pursuing justice for Rizwana and preventing such heinous atrocities from recurring.



Unified Support for Rape Victims: In a candid conversation with Dawn News, Chairperson NCRC Ayesha Raza Farooq highlighted the critical need for a unified approach to support rape victims, advocating for collaborative efforts among the police, prosecution, judiciary, and civil society. This approach aims to streamline the process, ensuring prompt and thorough investigations, effective prosecution, and sensitive judicial proceedings.

Podcast on Legal Reforms: The Chairperson Ayesha Raza Farooq participated in a podcast Talking IDEAS with Dr. Faisal Bari, Dean, School of Education, LUMS, where she discussed the NCRC's efforts to criminalize CDL and bring about legal reforms.

The NCRC had proactively proposed amendments to the Pakistan Penal Code (PPC) to criminalise child domestic labour, she added.

Pirbhu Satyani, a member of the NCRC representing Sindh, said the commission had in partnership with Unicef conducted a knowledge attitude and practices (KAP) survey focusing on child marriages, child labour and violent discipline.

The session proved invaluable in equipping the NCRC staff and members with a profound

understanding of the legal and technical aspects of criminal investigations. Divided into two parts, the presentation covered procedural formalities in criminal cases, such as registering FIRs, conducting investigations, and submitting final reports to the court. Additionally, it offered an overview of the legal framework pertaining to crimes and violations related to children. Armed with a deeper understanding of investigation protocols, the NCRC is now better positioned to follow up on child rights violation cases, ensuring that the right procedures are adhered to.
